Sarah Spoke on the state budget, including how it is formulated and how it is currently being dealt with in the North Carolina General Assembly. She spoke about the debate on tax reform, how it has impacted budget negotiations, and public opinion in relation to the media's display of events. She also informed everyone of the many resources that the John Locke Foundation has to offer, including free email newsletters and the Carolina Journal.
